Offeror's Questions to RFP:

11. Our company was recently awarded a contract on CATS+ and we are looking to bid on the Technical Writer with one of our small business partners. Can you provide any further insight on the interviewing process? I notice that resume are due 8/26 but a start date is not scheduled until November 4, 2019.

Answer: Resumes received are reviewed by an Interview Team, they determine the top candidates to be interviewed, those companies are notified via email the date and time for their candidate to be interviewed, we interview all the selected candidates and make an award determination, seek the necessary approvals to award a contract and then confirm the actual start date for the candidate with the successful Offeror and schedule a Kick-Off Meeting with the Offeror and the successful candidate.

12. Is there a possibility for the 6 month contract work to be extended? **Answer:** No.

13. Is there an expectation of work commencing prior to November 4th date? **Answer:** There is a possibility of work commencing prior to November 4th if LABOR is able to complete RFR award process earlier.

14. Can we have more clarification regarding the amount of time available the contract for telework? **Answer:** See answer to question no. 10.

15. Once a candidate is submitted, and if at time of award that candidate is no longer available will DLLR follow the substitute process outlined in the CATS + Master Contract or will they not allow substitutions? **Answer:** LABOR will follow the CATS+ Master Contract requirements.

16. In the RFR it states Email 1 of 2 for the proposal submittal must contain a password protected file with RFR Attachments 1, 3-8. Will these need to be in one password protected document, or 8 individual password protected documents attached in the email?

Answer: Please follow the requirements outlined in Section 5 – Required Submissions.

17. Will bids be accepted from newly awarded Master Contract holders who meet all the qualifications (with supporting documentation), but are still waiting for eMMA Service Desk to correct company profile to reflect their contract status and SBR certification?

Answer: Offeror only needs to be a current CAT+ Master Contractor.

9. If we propose for this opportunity, will it preclude us from responding to the resulting TORFP? Will it be deemed a Conflict of Interest?

Revised Answer: Based upon Section 13-212.1 of the State Finance and Procurement Article, yes the Technical Writer's company would be precluded from responding to the RFP on the basis of a conflict of interest.

10. I see that remotely will be entertained. How often would the candidate need to be onsite for this requirement?

Answer: The candidate would be on site 80 to 90% of the time. Working remotely will only be a small percentage and periodic.
