THIS MODIFICATION No. 5 (the "Modification") is made this 9<sup>th</sup> day of December, 2019, by and between AT&T Mobility National Accounts, LLC (the "Contractor") and the State of Maryland, acting through the Department of Information Technology (the "Department"), to the above-referenced Participating Addendum under the Western States Contracting Alliance ("WSCA") Master Service Agreement for Services of Independent Contractor, Contract No. 1907 (the "Master Contract").

**WHEREAS**, the Department and the Contractor entered into the Participating Addendum on January 8, 2013;

**WHEREAS**, on or about May 1, 2014, the National Association of State Procurement Officials ("NASPO"), the successor organization to WSCA, amended the Master Contract with the Contractor, thereby extending the term of the Master Contract from October 31, 2016 to June 30, 2019;

**WHEREAS**, the Department and the Contractor entered into Modification No. 1 on September 22, 2016 to extend the term of the Participating Addendum to June 30, 2019;

**WHEREAS**, the Department and the Contractor entered into Modification No. 2 on January 8, 2018 to incorporate the ability to purchase Custom FirstNet Mobile Phone Plans for the term of the Participating Addendum;

**WHEREAS**, on or about March 22, 2019, NASPO amended the Master Contract with the Contractor, thereby extending the term of the Master Contract from June 30, 2019 to December 31, 2019;

**WHEREAS**, the Department and the Contractor entered into Modification No. 3 on June

28, 2019 to extend the term of the Participating Addendum to August 31, 2019;

**WHEREAS**, the Department and the Contractor entered into Modification No. 4 on August 19, 2019 to extend the term of the Participating Addendum to December 31, 2019;

**WHEREAS**, on or about August 5, 2019, NASPO amended the Master Contract with the Contractor, thereby extending the term of the Master Contract from December 31, 2019 to December 31, 2020 (see Exhibit A attached hereto and incorporated herein); and,

**WHEREAS**, the Department and the Contractor now seek to extend the term of the Participating Addendum to December 31, 2020 and to update the parties' contacts.

**NOW THEREFORE**, in consideration of the Recitals which are hereby made a substantive part hereof, and the promises and the covenants herein contained, the adequacy and sufficiency of which are duly acknowledged, the parties agree as follows:

1. That Section 1.2 of the Participating Addendum is deleted in full and replaced with the following:

The parties hereby create this Participating Addendum governing the purchase of wireless telecommunications services and equipment offered in the WSCA (now NASPO) Master Service Agreement. This Participating Addendum shall be effective upon approval by the Maryland Board of Public Works until December 31, 2020, unless sooner terminated as provided herein.

2. That Section 4 of the Participating Addendum is deleted in full and replaced with the following:


