THIS MODIFICATION No. 5 (the "Modification") is made this 21 day of December, 2020, by and between T-Mobile USA, Inc. (the "Contractor") and the State of Maryland, acting through the Department of Information Technology (the "Department"), to the above-referenced Participating Addendum under the Western States Contracting Alliance ("WSCA") Master Service Agreement for Services of Independent Contractor, Contract No. 1907 (the "Master Contract").

**WHEREAS**, the Contractor and the Department entered into the Participating Addendum on November 15, 2012;

**WHEREAS**, on or about June 18, 2015, the National Association of State Procurement Officials ("NASPO"), the successor organization to WSCA, amended the Master Contract with the Contractor, thereby extending the term of the Master Contract from October 31, 2016 to June 30, 2019;

**WHEREAS**, the Department and the Contractor entered into Modification No. 1 on September 22, 2016 to extend the term of the Participating Addendum with the Contractor to June 30, 2019;

**WHEREAS**, on or about March 22, 2019, NASPO amended the Master Contract with the Contractor, thereby extending the term of the Master Contract from June 30, 2019 to December 31, 2019;

**WHEREAS**, the Department and the Contractor entered into Modification No. 2 on June 28, 2019 to extend the term of the Participating Addendum with Contractor to August 31, 2019;

**WHEREAS**, the Department and the Contractor entered into Modification No. 3 on August 19, 2019 to extend the term of the Participating Addendum with Contractor to December 31, 2019;

**WHEREAS**, on or about August 19, 2019, NASPO amended the Master Contract with the Contractor, thereby extending the term of the Master Contract from December 31, 2019 to December 31, 2020 (see Exhibit A attached hereto and incorporated herein); and,

**WHEREAS**, the Department and the Contractor extended the term of the Participating

Addendum to December 31, 2020;

**WHEREAS**, the Department and the Contractor seek to extend the term of the Participating Addendum to March 31, 2020;

**NOW THEREFORE**, in consideration of the Recitals which are hereby made a substantive part hereof, and the promises and the covenants herein contained, the adequacy and sufficiency of which are duly acknowledged, the parties agree as follows:

1. The term of the Participating Addendum is extended until March 31, 2021, unless sooner terminated as provided therein,
2. That the individual executing this Modification No. 5 on behalf of the Contractor warrants that s/he has full authority to execute this Modification to bind company principals.
3. That the value, if any, of this Modification No. 5 is \$0.00.
4. That, except as expressly modified herein, all of the provisions of the Participating Addendum remain in full force and effect and are hereby ratified and confirmed.
